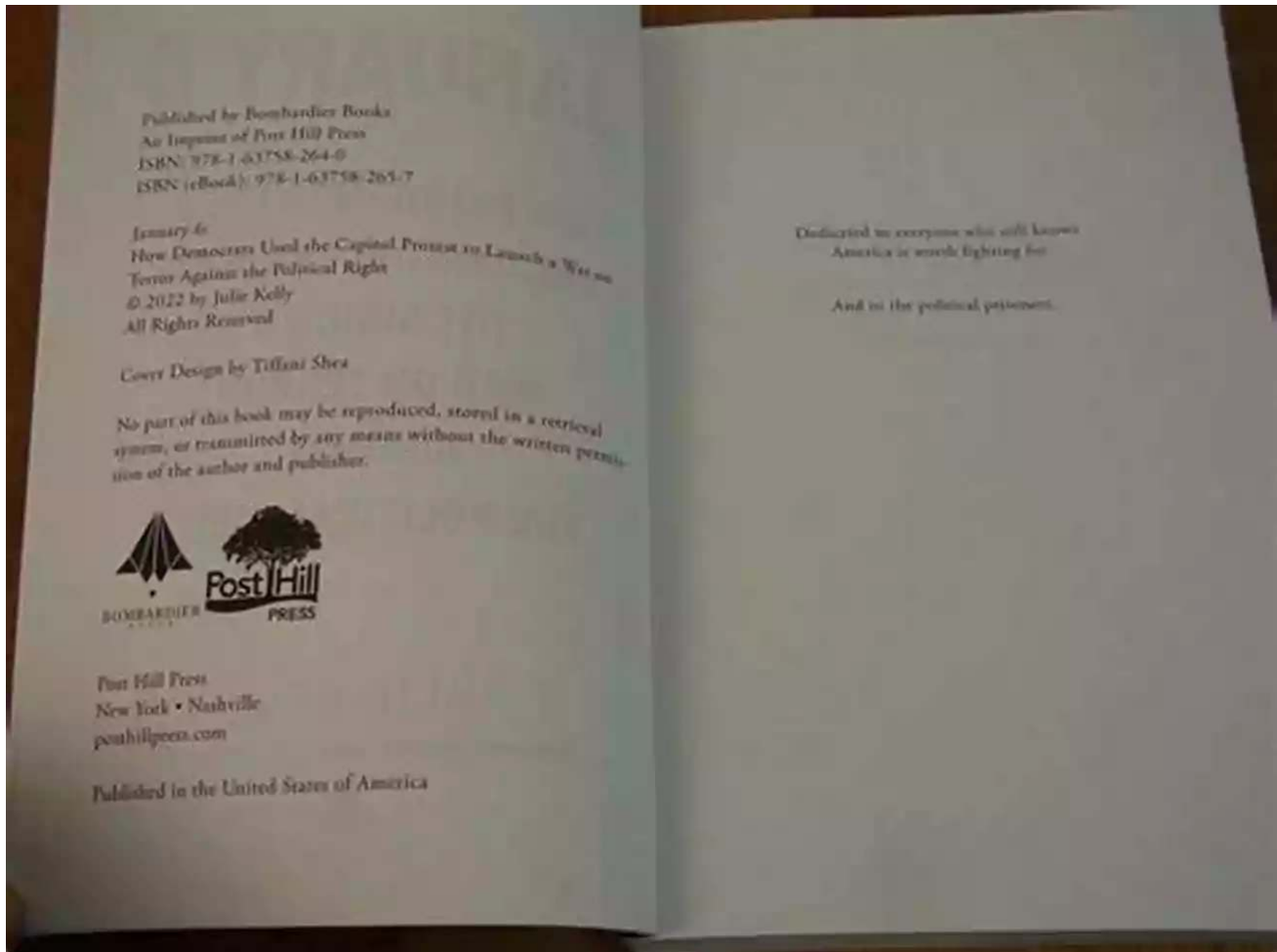


# How Democrats Used The Capitol Protest To Launch War On Terror Against The
